# MICHELLE A. QUINN, PARTNER

Prior to that, she was an intern in a large international firm in Dublin where she was involved in cases before employment related statutory tribunals. Additionally, Michelle has lectured at Independent Colleges Dublin in all aspects of employment law including redundancy, recruitment and application process, employer liability, constructive dismissal, HR practice and procedures. She is an accredited Civil and Commercial Mediator in Ireland and has served on the Ethics Committee of the Mediators' Institute of Ireland from 2007 – 2008.

While undergoing the re-qualification process in BC, Michelle articled with an employment law boutique firm in Vancouver, BC where she was involved in cases before the courts of BC (Provincial and Supreme Court), the BC Human Rights Tribunal and the BC Employment Standards Branch. She was seconded to a labour law firm, Bobert & Burton, to complete her articles. When she was called to the Bar in May 2013, Michelle joined Bobert & Burton as an associate and practiced exclusively in the area of labour law. She worked closely with Unifor, Canada's largest private sector union, in preparing grievance arbitrations. She also advised and assisted in unfair labour practice complaints before the Labour Relations Board and Canadian Industrial Relations Board in BC and Alberta.

To date, much of Michelle's practice focuses on specializing in employment and
